FEES

I agree to pay SWEET HOME RESCUE ("SHR") an adoption fee of USD 240.00, which is refundable within 14 days, since the date of transfer, or three (3) days from the date of arrival at LAX, whichever earlier, provided that the adopter returns the living dog to a SHR representative and releases SHR of any further liabilities. _____

SALES & RETURNS

I agree that above named dog is being adopted for myself and will not be sold, adopted, or given to another party in the future. I agree not to engage in selling this dog to pet shops, or supplying the dog for raffles, lotteries, auctions or laboratories, or any other activities prohibited by law. After the initial 14-day period since the date of transfer or three (3) days from the date of arrival at LAX, should I at any time be unable to keep or care for the dog, I will contact and return the dog to the SHR representative. The dog may not be transferred to another owner without the expressed consent of SHR. I understand that I may have to travel to the main location of SHR in Irvine, CA to return the adopted animals above, and will provide all necessary travel expenses to safely send back the adopted animal. SHR reserves rights in reclaiming the dog, should it find my home to be unfit for any reason and by violation of this contract. When all the rights have been reverted to SHR, all fees received by SHR from me will remain non-refundable donation to SHR. _____

PROPER CARE

I agree to provide the dog with a good and safe home with proper care and attention. When my dogs go outdoors, they will be on a secure harness and wear proper ID. I also agree to identification microchip implanted in my dog if the dog does not already have one. I agree to comply with federal, state and local laws as well as ordinances, and any other relevant laws in relevant jurisdiction. I further agree to have the dog examined by a licensed veterinarian at least once a year and will keep all the necessary dog vaccinations up to date. Should there be any necessary veterinarian services needed due to negligence or lack of care, it will be my responsibility to pay all necessary medical bills and will be made payable to SHR when applicable. _____

CONDITION and OTHER WARRANTIES

SHR makes no warranties or statements regarding the dog's health or temperament. I agree and understand that while every effort is made to provide accurate history and assessment of a dog, SHR does not warrant a dog regarding medical status or behavior or disposition or age. It is further agreed that environmental changes may affect and change the temperament of the above named dog and that SHR has no liability or responsibility of any nature regarding later defects of the dog, or injuries or damage to any person or property that may be caused by the dog. I agree to indemnify and hold harmless SHR and its members or representatives against any and all past, present, or future claims of any injury or property damages to me or anyone else by this dog. _____

CONTACT INFORMATION

I give SHR permission to call me at any reasonable time to assure that the animal is being properly treated and cared for. I also agree to keep the rescue informed of my current home address and phone number within 10 days of change. I also agree that SHR will be promptly notified of my death in the event this dog survives me.

ATTESTATION

I certify that all statements I have provided on this form are true, based on my personal knowledge and belief. If it was found that any statements I have made on this form is not true, the dog can be confiscated and all the ownership rights will be reverted to SHR or its representatives.

I HEREBY ACKNOWLEDGE THAT I HAVE READ AND UNDERSTOOD ALL OF THE ABOVE TERMS AND CONDITIONS AND WILL KEEP THE DOG DESCRIBED HEREIN AS A FAMILY MEMBER. I UNDERSTAND THAT THIS IS A BINDING CONTRACT ENFORCEABLE BY LAW OF STATE OF CALIFORNIA.
